

Rebelle Starter Pack Giveaway Official Rules

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

By entering into this Sweepstakes, I accept the terms and conditions and set forth in these Official Rules. I confirm I am at least 18 years old. By entering the sweepstakes, I agree to sign up to receive newsletters and special offers from Rebelle Rally Enterprises, LLC. No Purchase Necessary. A Purchase Will Not Increase Your Chances of Winning. The Sweepstakes is subject to federal, state, municipal, and local laws and regulations and is void where prohibited.

Eligibility: Rebelle Starter Pack Giveaway (the “Sweepstakes”) is open to anyone who is at least eighteen (18) years of age that has a valid email address. Employees, independent contractors, interns, officers, directors, and agents of Sponsor and the associated company are not eligible to enter.
